 - **11.1.3.** Remaining present ARC member, Connie, expressed she would stay.
 - **11.1.4.** Kim offered to stay on the committee an additional 60 days to allow the Board time to improve on current grievances and address longstanding issues of performance with ACS West. However, the offer is contingent on other ARC members choosing to stay with her. The committee cannot operate with such low membership. Chairman asked members again if they would be willing to also stay if only for 60 days; no takers.
