- 1. Meeting Call to Order: The meeting was called to order at 6:02 PM, by the President, Mr. Matt Cullather. Quorum was established with Directors Mr. Matt Cullather, Mr. Shawn Gitlin and Mr. Bill Donegan and Mr. Rob Laurent present. Ms. Yeager and Mr. King, of ACS, were also present.

- b) Gazebo roof replacement. ACS will request pricing from other roofing contractors and provide options to the BOD.

## 5. New Business:

- a) ARC Membership: Mr. Cullather made a motion to approve new ARC member. Mr. Laurent seconded and approved by unanimous vote.
- b) ARC Guideline amendments. Mr. Cullather made a motion to approve the edits to the ARC guidelines regarding hot tubs and firepits. Mr. Laurent seconded and approved by unanimous vote. Mr. Laurent made a motion to accept the ARC changes regarding building permit requirements as part of the homeowner application. Mr. Cullather seconded and approved by unanimous vote. Mr. Laurent made a motion to accept the ARC specifications regarding chicken coops. The motion was passed with three members in favor and one member against.
- 6. Member Voice: (7 members of the community were present)
  - a) Pool. A member asked about the pool dues for this year. The BOD was unaware of the cost.
  - b) Quarry. A member asked about if the BOD had a position on the blast from the nearby quarry. The BOD did not have a position on the matter.
