- 1) Meeting called to order- John
- 2) Quorum established: all board members present; Sam King and Martha Yeager from ACS West present

- 4) Old Business:
  - a. Boat ramp-John/ \$44k estimate, another estimate coming, new lake committee to be involved
  - b. Tennis Court-John/3 quotes to upgrade Tabled until Reserve Study completed
  - c. Website-Ed-Current company unwilling to provide a test portal. ARC just went through a major transition. Still on our agenda.
  - d. Security Cameras-Ed/8400 property...test conducted with no activity other than Christmas lights. Estimates between 20 and 30k plus monthly fee to monitor. No good answer to a good fit for us yet. Ring Door System seems to be our best solution. Unanimously approved to use the Ring Door System.
