As of now, the only expense is SwimMetro which was fully covered by this year's pool memberships. Other expenses covered by the HOA included a new rope for the dive well, basketball hoop, 5 umbrella stands, outdoor lighting and cameras (to be installed soon).

Mr. Robert Laurent thanked the committee for volunteering and reassured the committee the majority of the neighborhood stands behind them.

Mr. Lovato requested information regarding long term use of the clubhouse

Arnika clarified there will be no decisions made until winter/fall.
